Dear Sir/Madam,

We refer to the letter received by the Company on Friday, 14 July 2023 from PT Bursa Efek Indonesia ("**IDX**") Number S-05705/BEI.PP2/07-2023 on Clarification concerning News in Mass Media. The IDX requested clarification concerning news coverage on the Company in *Kontan* with the title "*Garap Dua Proyek IKN Nusantara, Wika Gedung (WEGE) Bukukan Proyek Rp1,2 Triliun*" (Undertaking Two Projects for IKN Nusantara, Wika Gedung (WEGE) Books Projects worth Rp 1.2 Trillion) dated 14 July 2023. For and on behalf of the Company, we wish to inform you as follows:

1. Clarification on the news:

a. On the facts of the news

**Response:** It is true that the Company has secured new contracts of Rp1.2 trillion in 2022. The contracts are for: a) construction of dwellings for IKN construction workers with a gross contract value of Rp442 billion; and b) construction of offices for the Coordinating Ministry for Maritime & Investment Affairs with a gross contract value of Rp746 billion. Therefore, total contracts from IKN projects at time of writing is worth Rp1.2 trillion.

As for IKN projects in 2023, the Company is currently participating in tender processes for the flats of civil servants (ASN), in addition to some office complex projects from the Government.

b. Actions by the Company to complete the projects

**Response:** The Company strives to deliver the best results through BIM technology as well as faster construction time through Modular Volumetrics technology in ongoing tenders for IKN projects. This is to ensure that the Company can secure new contracts from its targeted IKN projects.

c. Impacts of the event on the Company's operating activities

**Response:** There is no impact on the Company's operating activities.
