Dear Sir/Madam,

We refer to the letter received by the Company from PT Bursa Efek Indonesia (“**IDX**”) Number S-02443/BEI.PP2/03-2024 on Clarification concerning News in Mass Media. The IDX requested clarification concerning news coverage on the Company in *Kontan* with the title “*WEGA Mengerek Perolehan Kontrak*” (Wika Gedung (WEGA) Raises Contract Wins) dated 7 March 2023. For and on behalf of the Company, we wish to inform you as follows:

1. Clarification on the news:

a. On the facts of the news

**Response:** The news in *Kontan* is true, where PT Wijaya Karya Bangunan Gedung Tbk (“**Company**”) aims to secure new contract worth Rp5.07 trillion in 2024.

b. Actions the company has taken and will take on the secured contracts

**Response:** The Company is currently working on projects that have been secured in 2023, some of which are the IKN projects aimed to be completed by the end of 2024. The IKN projects are construction of Building 1 of the Coordinating Ministry of Maritime and Investment Affairs, Residence of Presidential Security Force of Indonesia (Paspampres), and Office of Wing 1 of the Ministry of Public Works and Housing (“**PUPR**”). In addition to ongoing projects, the Company also aims to secure new projects in 2024 with a total contract value of Rp5.07 trillion. This information has been reported in *Kontan*.

c. Impacts of the contract on the Company's financial condition and operating activities

**Response:** The contract secured by the Company is expected to positively impact the Company's financial condition and operational activities.

d. Briefly describe the contracts secured and projects as of February 2024

**Response:** As of January 2024, the Company has secured Rp169.39 billion in new contracts to construct the InaTEWS Building for the

Meteorological, Climatological, and Geophysical Agency ("BMKG")  
and modular portable office for the Kencing Drain project in Kudus.

- e. In the news, it was stated that the Government Budget for infrastructure increased to Rp146.98 trillion in 2024. Has the increased budget been confirmed to be allocated for IKN projects which will raise WEGE's contract wins in 2024?

**Response:** According to information on the Ministry of PUPR website, the Ministry's budget for FY2024 is Rp146.98 trillion. The budget's focus is to accelerate completion of ongoing infrastructure projects and optimising existing infrastructure. The Company understands that it is possible that a portion of the budget will be allocated for IKN projects, which will have a positive impact on the Company. In its budget plan for 2024, the Company has selected the projects for its new contract target.

2. Information or other material events that may affect the Company's business continuity and may affect its share price.

**Response:** The Company has disclosed and will always disclose material information/events which may affect the Company's business continuity and share price, as required by prevailing laws.
